NOTICE is hereby given that:

1. The 1<sup>st</sup> Extra Ordinary General Meeting of the Calender Year 2016 of the members of Hella India Lighting Limited (CIN : U74899DL1959PLC003126) will be held at Hotel Aravali Villa, F.H.-1, Bandh Road, near Nitesh Kunj Farm House, N.H.-8, Rajokari, New Delhi - 110038, India on Thursday, 28<sup>th</sup> day of April 2016 at 9:00 A.M.
2. The Notice of 1<sup>st</sup> EGM have been sent physically to all the Members of the Company at their registered addresses with the Company. The physical dispatch of notice of 1<sup>st</sup> EGM has been completed on 4<sup>th</sup> April 2016. Members are hereby informed that in compliance with the provisions of section 108 of the Companies Act, 2013, read with Rule 20 of The Companies (Management and Administration) Rules, 2014, (i) the Company is pleased to provide members the facility to exercise their right to vote at the EGM by Electronic means and business may be transacted through voting by electronic means provided by Central Depository Services (India) Limited (CDSL). The instructions for e-voting are given in the Notice of the EGM. (ii) The remote e-voting period begins on 25<sup>th</sup> April, 2016 (9.00 a.m.) and ends on 27<sup>th</sup> April 2016 (5.00 p.m.) (iii) The members of the Company holding shares either in physical or dematerialised form as on the cut-off date, being 22<sup>nd</sup> April, 2016 may cast their vote electronically. (iv) A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the meeting through ballot paper. A person, who acquires shares and become shareholder of the Company after dispatch of notice and holding shares as on the cut-off date, can do remote e-voting by generating their login-id and password as detailed in the notice of the 1<sup>st</sup> EGM which can also be downloaded from the website of the Company i.e. [www.hella.co.in](http://www.hella.co.in). (vii) A member may participate in the meeting even after exercising his right to vote through remote e-voting, but shall not be allowed to vote again at the meeting.
